Proclamation

From the Governor of the State of Maryland

NATIONAL SAFE DIGGING MONTH APRIL 2022

WHEREAS, Thousands of times each year, the underground infrastructure in Maryland is damaged by those who do not have underground lines located prior to digging, resulting in service interruption, environmental damage, and threat

to public safety; and

WHEREAS, Maryland's Underground Facilities Law provides guidelines for safe digging practices whenever a contractor performs executions or demolitions, including the establishment of a "unce all" Miss Utility notification system. This system is free to contractors and homeowners allke, and is vital in helping avoid disruption of service and

ensuring the safety of the people of Maryland; and

WHEREAS, The Miss Utility Call Center provides a toll-free telephone number in order to promote public safety and help reduce damages to underground facilities, thereby reducing the loss of critical public services and the loss of time

and money to contractors, underground facility operators, and taxpayers; and

WHEREAS, Damage prevention is a shared responsibility; by using safe digging practices, the excavators and homeowners of Maryland can save time and money and help keep our infrastructure safe and connected.

NOW, THEREFORE, I, LAWRENCE J. HOGAN, JR., GOVERNOR OF THE STATE OF MARYLAND, do hereby proclaim APRIL 2022 as NATIONAL SAFE DIGGING MONTH in Maryland, and do commend this observance to all of our citizens.

EVOLUTION OF THE MD MISS UTILITY LAW

The 2006 Federal Pipes Act was passed by Congress requiring all states to establish pipeline safety oversight programs.

SB 811 passed by the MD legislature establishing the MD Underground Facilities Damage Prevention Authority.

A complete overhaul of the 2010 Miss Utility law was completed and passed by the MD Legislature and became law on March 11, 2021.




The nationwide one-call system was established by the FCC. Now by just dialing 811 in your area you can reach your areas' one-call center to request marking.

A work group comprised of MD stakeholders began meeting in order to set the groundwork for the Authority. The Authority became operational in 2012.

THE NPV PROCESS

- VIOLATIONS CAN ONLY BE REPORTED VIA THE AUTHORITY'S WEBSITE AT:
 <u>WWW.MDDPA.ORG</u>. OR BY USING THE EITHER OF IT'S MOBILE APPS (APPLE OR ANDROID). A FEE OF \$200 IS CHARGED TO HELP DEFRAY PROCESSING.
- AFTER AN INVESTIGATION OF THE NPV IT IS DECIDED WHETHER A VIOLATION OF SUBTITLE 1 OF TITLE 12 OF THE MARYLAND PUBLIC UTILITIES ARTICLE HAS OCCURRED
- THESE FINDINGS ARE THEN PRESENTED TO THE AUTHORITY MEMBERS FOR THEIR REVIEW AND DETERMINATION OF PENALTIES USING THE STANDARDIZED FINING MATRIX (SFM).
- IN THE 2016 MARYLAND COURT OF APPEALS RULING (RELIABLE CONTRACTING V. MARYLAND UNDERGROUND FACILITIES DAMAGE PREVENTION AUTHORITY) THE AUTHORITY WAS DIRECTED TO USE THREE FACTORS TO DETERMINE A FAIR AMOUNT OF CIVIL PENALTY:
 - A) SERIOUSNESS OF THE VIOLATION:
 - B) INTENT ("GOOD FAITH") OF THE VIOLATOR,
 - C) PAST-HISTORY OF VIOLATIONS.





DUE PROCESS

- IF THE AUTHORITY DETERMINES THAT A CIVIL PENALTY AND/OR TRAINING OR OTHER REQUIREMENT SHOULD BE IMPOSED AFTER THE REVIEW, THE AUTHORITY NOTIFIES THE PROBABLE VIOLATOR VIA RECOMMENDATION LETTER; WHICH MUST BE SENT BY CERTIFIED U. S. MAIL. TO INSURE RECEIPT OF THE FINDINGS.
- THE PROBABLE VIOLATOR HAS FORTY-FIVE DAYS TO CONTACT THE AUTHORITY FROM THE DATE OF THE RECOMMENDATION LETTER.
- THE VIOLATOR MAY THEN EITHER ACCEPT THE FINDINGS OF THE AUTHORITY AND PAY THE FINE, UNDERTAKE DAMAGE PREVENTION TRAINING OR ANY OTHER AUTHORITY REQUIREMENT;
- OR REQUEST A FORMAL HEARING BEFORE THE AUTHORITY.



LEGISLATIVE RELIEF

- HOUSE BILL 994/SENATE BILL 789
- NOW ALLOWS A CONTRACTOR TO CHOOSE A START WORK DATE WHEN NOTIFYING THE ONE-CALL SYSTEM.
- ..."THE TICKET SHALL INCLUDE A RESPONSE DATE AND TIME FOR OWNER-MEMBERS OR THEIR CONTRACT LOCATORS THAT CORRESPONDS WITHTHE START WORK DATE SELECTED BY THE PERSON WHO INITIATED THE TICKET."
- ..."A TICKET IS VALID FOR 12 BUSINESS DAYS AFTER
 THE SELECTED START WORK DATE ON A TICKET THAT
 IS TRANSMITTED BY THE ONE—CALL SYSTEM TO AN
 OWNER—MEMBER OR THEIR CONTRACT LOCATOR."
- THIS WILL CHANGE WILL GO INTO EFFECT ON JUNE 1, 2022

§12-121. EMERGENCY EXCAVATION

- "EMERGENCY" MEANS A SUDDEN OR UNEXPECTED OCCURRENCE INVOLVING A
 CLEAR AND IMMINENT DANGER DEMANDING IMMEDIATE ACTION TO PREVENT
 OR MITIGATE LOSS OF, OR INJURY TO, LIFE, HEALTH PROPERTY, OR AN ESSENTIAL
 PUBLIC SERVICE."
- THIS SECTION APPLIES TO ANY ACTION TAKEN TO ADDRESS AN EMERGENCY FROM THE TIME THE EMERGENCY ARISES UNTIL A STANDARD TICKET IS INITIATED AND IS VALID UNDER §12-124 OF THIS SUBTITLE, INCLUDING ANY WORK ASSOCIATED WITH STOPPING OR MITIGATING THE "EMERGENCY".


THE OWNER-MEMBER OR ITS CONTRACTOR LOCATOR SHALL...

- RESPOND TO AN EMERGENCY NOTICE AS SOON AS POSSIBLE BUT NOT LATER THAN 2
 HOURS FROM THE TRANSMISSION OF THE TICKET FROM THE ONE-CALL CENTER AND
 INITIATE A DIALOGUE WITH THE TICKET REQUESTOR ON THE TIME OF ARRIVAL OR AN
 AGREED UPON TIME AND DATE.
- THE LOCATOR MUST BEGIN THE MARKING PROCESS WITHIN 3 HOURS AND THE CONTRACTOR MUST BE ON SITE OR ON THE WAY TO JOB SITE

EXTENT OF WORK

§12-101(N) "EXTENT OF WORK"

MEANS A CLEAR AND CONCISE

DESCRIPTION OF WORK TO BE DONE AT
A PROPERTY,

INCLUDING THE PROPERTY ADDRESS OR SPECIFIC DISTANCE AND <u>DIRECTION</u>
FROM A SPECIFIED POINT, NOT TO
EXCEED 1,320 FEET,

THAT COMPLETELY DEPICTS THE SCOPE OF WORK

AND THAT THE EXCAVATOR CAN

COMPLETE WITHIN THE DESIGNATED LIFE

OF THE TICKET.

FACILITY OWNERSHIP

"..."OWNER" MEANS A PERSON THAT: OWNS OR OPERATES AN UNDERGROUND FACILITY; AND HAS THE RIGHT TO BURY AN UNDERGROUND FACILITY. "OWNER" INCLUDES: A PUBLIC UTILITY; TELECOMMUNICATIONS CORP.; CABLE TELEVISION CORP.; A POLITICAL SUBDIVISION; A MUNICIPAL CORP.; A STEAM HEATING CO.; AN AUTHORITY; AND A UNIT OF THE STATE..."

"...AN "OWNER-MEMBER" OR ITS CONTRACT LOCATOR SHALL MARK ITS UNDERGROUND FACILITY A PROPOSED EXCAVATION OR DEMOLITION THAT IS SPECIFIED IN THE EXTENT OF WORK CONTAINED IN THE TICKET..."

§12-131 NON-EXCAVATION TICKETS FORMALLY DESIGNER TICKETS

- A PERSON MAY INITIATE A "NON-EXCAVATION" TICKET REQUEST BY NOTIFYING THE ONE-CALL SYSTEM SERVING THE GEOGRAPHIC AREA COVERING THE PLANNED PROJECT IF THE PROJECT MAY REQUIRE EXCAVATION OR DEMOLITION.
- MAY INITIATE ONLY ONE TICKET REQUEST FOR A SINGLE PROJECT.
- IN CONNECTION WITH A NON-EXCAVATION TICKET REQUEST, A PERSON MUST INDICATE THAT THE REQUEST IS FOR DESIGN PURPOSES ONLY AND MAY NOT BE USED FOR THE PURPOSE OF EXCAVATION OR DEMOLITION.
- THE ONE—CALL SYSTEM SHALL PROVIDE THE PERSON REQUESTING A
 NONEXCAVATION DESIGNER TICKET AN ACCURATE MEANS OF CONTACT FOR EACH
 UNDERGROUND FACILITY WITHIN 2 BUSINESS DAYS.
- EACH UNDERGROUND FACILITY OWNER SHALL MAINTAIN CURRENT VALID CONTACT INFORMATION WITH THE ONE-CALL SYSTEM FOR PERSONS TO CONTACT.



LOCATABLE/DETECTABLE

§12-104 (A-C) - NEW SECTION

- A) THIS SECTION APPLIES TO: (1) COMPLETE REPLACEMENT OF AN EXISTING UNDERGROUND FACILITY; (2) UNDERGROUND STORM DRAIN SYSTEMS AND APPLICABLE DEVICES; AND (3) AN EXISTING PREVIOUSLY DETECTABLE UNDERGROUND FACILITY OR LOCATABLE UNDERGROUND FACILITY.
- (B) EXCEPT AS OTHERWISE PROVIDED IN § 12–129 OF THIS SUBTITLE, ON OR AFTER OCTOBER 1, 2021, ALL NEWLY INSTALLED UNDERGROUND FACILITIES SHALL BE DETECTABLE OR LOCATABLE. (C) NOT LATER THAN OCTOBER 1, 2021, ANY PREVIOUSLY DETECTABLE UNDERGROUND FACILITY OR UNDERGROUND FACILITY MUST BE RESTORED TO BE DETECTABLE OR LOCATABLE.

§12-129 – TRACER WIRE ON PRIVATE PROPERTY

"...(A) SUBJECT TO SUBSECTION (C) OF THIS SECTION, ANY NEW OR REPLACEMENT PIPING THAT IS BURIED OR INSTALLED FOR THE PURPOSES OF CONNECTING A BUILDING TO A WATER SUPPLY SYSTEM, A SEWERAGE SYSTEM, AN UNDERGROUND STORM DRAIN SYSTEM, OR ANY OTHER APPLICABLE DEVICE SHALL BE BURIED OR INSTALLED WITH A WIRE OR AN EQUIVALENT PRODUCT OR TECHNOLOGY THAT MAKES THE PIPING DETECTABLE OR LOCATABLE. (B) ANY WIRE USED TO COMPLY WITH SUBSECTION (A) OF THIS SUBSECTION SHALL..."



CROSSBORES

§ 12-101(F) "CROSS—BORE" - MEANS AN INTERSECTION OF AN EXISTING UNDERGROUND FACILITY BY A SECOND UNDERGROUND FACILITY RESULTING IN CONTACT BETWEEN THE TWO FACILITIES THAT RESULTS IN THE ORIGINAL FACILITY BEING DAMAGED, DISLOCATED, OR DISTURBED.

§12-131 - NONEXCAVATION TICKETS

(D) IN THE CASE OF AN OBSTRUCTION CAUSED BY A SUSPECTED CROSS—BORE: THE PERSON INTENDING TO REMOVE THE OBSTRUCTION SHALL NOTIFY THE ONE—CALL CENTER AND REQUEST A NONEXCAVATION TICKET FOR A SUSPECTED CROSS—BORE WHICH WILL BE TRANSMITTED TO ALL PERTINENT OWNER— MEMBERS IN THE GEOGRAPHIC AREA INDICATED FOR THAT TICKET; AND

(2) EACH OWNER-MEMBER SHALL TAKE WHATEVER ACTION IT CONSIDERS NECESSARY TO RESPOND TO THIS NOTIFICATION.
