Approval of Minutes:

The minutes for the 12/9/10 meeting were distributed electronically prior to the Board meeting by the Secretary (Note: The Board Meeting scheduled for 1/27/11 was cancelled due to weather). Motion was made by to approve the minutes as presented by Scott Flanigan, and was seconded by Mike Moulds. Motion approved.

Treasurer's Report:

Doug Myers was not able to attend the meeting, and his report dated 2/22/11 was distributed to the Board members electronically prior to the meeting. The checking account balance as of 1/25/11 was \$81,963.63, while the Money Market balance was \$8,940.44. The receipts totaled \$305.00, while expenses were \$711.18. The total balance of both the checking and money market accounts as of 2/22/11 was \$90,497.89. Motion to adopt the Treasurer's report was made by Greg Africa, and was seconded by Scott Flanigan. Discussion, motion carried.

Motion to approve by Greg Africa; and was seconded by Bob Sebastian. Approved. Including these four new members, the membership headcount as of this meeting is as follows: 284 Members; 232 Associate Members; 38 retired; and 21 Life & Honorary Members Total Membership = 575 (249 UNPAID OR 44%)

Committee Reports:

Program & Conference Committee: (Co-Chairmen Hudson Myers and Paul Kahl) -

Hudson Myers reported that Paul Kahl and he are working on the Fall 2011 Conference program, and the Spring Conference on May 10 is set for the Oregon Ridge Park facility, and the technical program has come together nicely with subjects that should appeal to all facets of Public Works departments. He hopes to have the program end close to 3:00 pm as possible. The Spring Golf tournament will be held at the Greystone GC facility on May 9th, with registration starting at 8:00, and a shotgun start at 9:00. Lunch will be served after golf along with the announcements and awarding of gift certificates to the various team, and individual winners.

The fall Conference will be held at the Clarion Hotel, and it will take place from 9/22-9/24, and once again, the golf tournament will be held at the Bay Club in Berlin.

Scholarship Committee: (Mike Errico and Dale Coppage – Co-Chairmen) – Dale distributed two reports to the Board entitled: "Roger H. Willard Scholarship Committee: -February 2011 Update"; and "Strategic Planning Session". The first report was stated that that our end of year account with the U of Md. Scholarship Investment fund was \$2,000 over the "corpus" amount, which means that we have \$2,000 of the needed \$ 16,862.00/year that funds the four partial civil engineering scholarships at the Clarke School of Engineering in C.P. In response to a "charge" given to the Scholarship Committee by the CEAM Board of Directors to establish long term goals for future scholarship sponsorships to not only students at local colleges, but possibly to existing County professional, or other Associate Members of CEAM to assist them with advancing their educational goals as they apply to the public works arena here in Maryland. (see: attached) At Dale's request, Hudson made a motion that stated that the Scholarship Committee goals were responsive to the Board's request and that the Committee should continue to implement some of the stated goals in the coming months. The motion was seconded by Greg Africa. Motion was passed unanimously.

Legislative Committee: (Chairman Bob Martin) - Bob Martin distributed copies of his legislative update to the Board that indicates that as of 1/26/11, there were 207 Senate Bills, and 160 House Bills introduced in he legislature. The bills of interest to the Committee and members of CEAM are: SB85/HB70-Budget Bills; SB87/HB72-Budget reconciliation Act; SB160-requires on-site nitrogen removal from sewage disposal systems; SB176 – establishes MD electric vehicle infrastructure Council;SB1822 – establishes Md Health Benefit Act of 2011; SB198- established single lot subdivide into two lots is subject to SWM regs; HB103- Allows farm vehicles a 5% gross load variance if loaded off-road; HB1109- Prohibits SHA from placing a sign on a FA Primary Highway System if that route is a Scenic Byway; HB116- Allows Garrett County to regulate setbacks for commercial wind turbines and to set a fee for decommissioning the turbines. In addition, Bb also distributed a copy of SB404 that deals with MDE and the permitting for sludge land applications.
