#### **Approval of Minutes:**

The minutes for the January 25, 2007 meeting were reviewed. Motion by Kevin Beachy, seconded by John redden, for approval of the minutes. Motion approved.

#### Treasurer's Report:

Doug Myers was able to attend the meeting, and his report dated 2/20/07 was distributed to the Board members. The checking account balance as of 1/23/07 was \$ 45,108.02, while the Money Market balance was \$ 8,356.13. The receipts totaled \$ 2,230.00, while expenses were \$ 660.25. The total balance of both the checking and money market accounts as of 2/20/07 was \$ 55,033.90. Motion to adopt the Treasurer's report was made by Bob Cooper, seconded by Steve Zahn. Discussion, motion carried.

#### **Committee Reports:**

**Spring '07 Conference Report**: **(Chairman John Redden)** –The registration packages are mailed, Bob Summers will be the Keynote Speaker, and all other speakers have been secured

for the technical program. The conference is set for May 3-5, 2007, and the conference will be held at the Ramada Inn in downtown Salisbury

Fall '07 Conference Report: (Chairman John Redden) – The Clarion will be the conference headquarters, and the conference will be held from September 20-23, 2007. John indicated that he is still waiting on confirmation that Secretary of Transportation, John Pecorri will be the "Keynote" Speaker, and that the technical program and speakers were being finalized.

**Legislative Committee:** (Chairman Bob Martin) – Bob reported that there were almost 1500 bills introduced by the House of Delegates for this session, and that he, Stu Taub, and Bill Korpman have been reviewing each bill for applicability to CEAM members. Bob then distributed a summary of pending House and Senate bills (13 HB, and 10 SB) for review by the Board members (see; attached). Bob pointed out some of the more astounding proposals to include a bill that will require a fee of \$0.25/square foot of proposed impervious surface for new developments, and there are proposals to raise the gas tax to \$0.12/gal, as well as raising the sales tax to 6.0%.

However, a discussion ensued regarding the theme of the MACO Conference to be "Home Safety: The Board felt that the two technical programs should most probably be focused on Roadway Safety, and Calming programs that are effective, as well as another topic addressing the "Environmental Programs" that are applicable to DPW and homeowners?

- Conference RFP for Outsourcing Registration Services John Redden & Mike Warring – Mike and John indicated that they were gathering some names of firms that can provide the necessary services, and would be increasing their research efforts following the forthcoming CEAM Conference in Salisbury in May

  the recently formed Program and Conference Committee with developing potential

John indicated then introduced Radka Nebesky and Deborah Vidmar, who serves ast the Director of the University's career Center. Radka presented an overview of the morning's program and tour of the facilities after lunch. Then, Radka introduced Dr. Haghani, who presented a power point presentation about the schools of

engineering, which included profiles of enrollments statistics for the University of Maryland's College Park Campus. Following the presentation, the Board members asked several questions concerning how CEAM could become more involved with the Civil, and Traffic Engineering and Environmental programs to insure that the students were not only aware of the four CEAM sponsored Scholarships, but to also have actual participation by CEAM members firms, or County representatives during the school year. Dr. Haghani suggested that he felt confident that these questions would be answered by Ms. Vidmar during the Board luncheon.

Ms. Vidmar indicated tat she and Radka would work closely with the coordination of such a program in the near future.
